Applications are invited from Indian nationals for the post of Junior Research Fellow (JRF) (on contract) in research project entitled "Design of novel heterogeneous catalysts for CO2 capture from flue gas based on density functional theory computations" Sanction order No. EEQ/2023/000011 sponsored by SERB, DST, Gov. of India.

Description and Objectives of the Project: The project is intended to learn from biological systems and develop chemical analogues that are suitable for applications in an industrial set-up for CO2 capture applications. Various aspects of the proposed study can be summarized as (a) Design and simulate the molecular structures of metal cluster supported metal oxide surfaces, (b) Check the stability of designed systems, (c) Design and simulate all the intermediates and transition states existing in the reaction, (d) Explore the possibilities of designed catalysts on the basis of potential energy surface developed for the CO₂ hydration reaction, (e) Characterization of molecular structures using IR spectra, NMR spectra, HOMO-LUMO, Band gap, atomic charge analysis, electron density difference analysis etc.
