
The Chairperson extended warm welcome to the members and thanked them for taking their time out to attend the meeting.

Chairperson also emphasized the urgency for upgrading the Training & Placement function as well as speedy review research activities & curriculum of the Institute across departments & programs/projects. He also requested the Director to put up a progress report in the next meeting.






**Item No. 39.14** : To consider the proposal for procurement of additional equipment under TEQIP-II.



**Item No. 39.19 : To consider the matter of signing of degree certificates of some passed out students following the detection of printing errors in degree certificates issued to them.**


